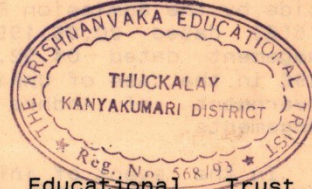

Sir,

I am directed to state that on consideration of the recommendations made by the Expert committee, the All India Council for Technical Education has accorded conditional approval to the Krishnavaka Educational trust, Sriparathasarthy temple, Thuckalay for establishment of Sree Krishna Polytechnic, Chidambarapuram, Nagercoil, Kanayakumari Dist. to run the following diploma programmes during the academic years 1994-95 and 1995-96.

The above approval is subject to fulfillment of following conditions.

1. One HOD in each course having AICTE prescribed qualifications should be recruited immediately.
2. The Management should obtain permission from the State Govt. of Tamilnadu immediately.
3. The Management should obtain affiliation from State Board of Technical Education immediately.
4. The Management should create infrastructure and other facilities in terms of faculty, lab., library etc. for conduct of second year classes well in advance before commencement of classes of that year.
5. The infrastructure and other facilities should be again reviewed in May, 1995 by an Expert Committee before actual admissions are allowed for the academic year 1995-96.
6. The institute should also comply with the general conditions of the AICTE as per Annexure to this letter.


